

GILA RIVER INDIAN COMMUNITY 2020 PRIMARY ELECTION September 15, 2020

About this Election

The Tribal Elections office has been receiving inquiries as to why there are only candidates for the Lieutenant Governor's seat in the Primary Election.

According to the Gila River Indian Community Election Ordinance: on the third Tuesday in September prior to a General Election; a Primary Election shall be held for the purpose of placing on the ballot at the ensuing General Election:

- 1. Two candidates for the office of Governor
- 2. Two candidates for the office of Lieutenant Governor
- 3. Two candidates for the office of Chief Judge
- 4. Ten candidates for the five offices of Associate Judge.

In the event that no more than two candidates for each of the office of Governor, Lieutenant Governor, and Chief Judge or no more than ten for five positions of Associate Judge file certificates of candidacy, then no Primary Election shall be held for that office.

This means that only the five candidates running for office of Lieutenant Governor will be placed on

the ballot for the Primary Election.

The two candidates with the most votes for this office will be placed on the General Election ballot.

On July 15, 2020, the Gila River Indian Community Council called for a special election to be held within 60 days in order to fill the vacant seat of a District Five Community Council Representative whose term ends June 2021.

This election will be held simultaneously with the Primary Election, September 15, 2020

Candidates who declared for a seat for the office of Associate Judge, Chief Judge and the office of Governor will be move onto the ballot for the General Election, November 3, 2020.

Tribal Elections is providing to you, the voter an opportunity to read all Candidates running for office in the Primary, District Five Community Council and General Election; their position on why they are seeking office in these tribal elections.

Please note, all written statements are being presented in the Candidates' own words; no edits were done by the Tribal Elections Program.

The skills I have learned from this position are to enforce tribal preference, settle claims and investigate allegations of employment discrimination. One thing I learned as a Compliance Officer is there is nothing more satisfying, personally and professionally, than to help our members gain employment.

I also worked for community court for 5 years total as a Bailiff/Court Security Officer, including 3 years as a supervisor. I was employed with the Community Court at the time when the Court transitioned into exercising jurisdiction under the Tribal Law and Order Act (TLOA) which brought felony cases to the community. I observed hundreds of cases and heard the judges make their decisions. From that experience, I learned the most important job of a judge is to listen to everyone. I also worked for the Tribal Gaming Office as a Gaming Inspector and part of my duties included being familiar with the legal agreements (gaming compact) between the State and Community, as well as various other tribal ordinances that govern gaming operations.

Our court handles thousands of criminal, civil, traffic, juvenile and appellate cases each year. Many of our Community members encounter the court system in difficult times and our court should operate in an efficient and competent manner to meet these challenging times. Our court needs judges that can manage the demands of a complex judicial system. As a judge, I manage a growing caseload that affects the lives of our Community members. My legal education and training allow me to make decisions based on the law and fairness. Over the years, I have heard from many Community members who are tired of repeat offenders, parents who do not live up to their obligations, and victims with no voice.

My core beliefs as a judge were formed over the years and guide me as I do my work. On the criminal side, repeat offenders should be held accountable and not be given sweetheart plea deals. I understand that people need help to avoid committing new crimes, that is why alternatives to jail such as substance abuse treatment and strict probation monitoring are important. I listen to the victims of violence and work to help heal the pain caused by domestic violence. Despite all the pain that comes with criminal cases, there are a few bright spots when someone successfully completes probation or graduates from substance abuse treatment. These are the beginnings of new lives and hopefully a better Community. I strongly believe that parents should be held responsible for raising and supporting their children. Making sure child support and parenting time orders are enforced is an important part of a judge's job. Our grandparents often care for their grandchildren and their voices should be respected and heard in court. In cases simple and complex, my decisions are based on the law and evidence. I work to ensure that my decisions and orders are followed so people do not have to come back to court over and over. I manage my courtroom so that people's time is respected and allow both sides to be heard. I strive to treat each person and case with respect and dignity. While not everyone will like the decisions I make, I hope that anyone who comes to our Community Court will have faith that justice is done.

I am running for Associate Judge to better serve my community and to change lives for the better. I also would like to make a difference by helping others be contributing members to society. I understand that crime, especially, can be a complex issue. So often, especially here at GRIC crime is a symptom of other issues such as addiction, grief, and lack of resources. I want to be able to attempt to understand the challenges that defendants face in order to craft punishments that are not only punitive, but truly rehabilitative. In cases with victims, I certainly want to be sure that their vision of justice is part of the calculus. In civil cases, I want to be sure community members find the Community Court to be accessible so that they can find practical ways to address issues that are important to them without feeling overwhelmed by the legal process. Growing up, my mother always told me to do my absolute best in any task I had started. As I got older, I was taught what's right is right and what is wrong is wrong but always seek the truth. My main goal, if elected, is to make a difference in our community and ensure that each hearing will be fair and impartial. Thank you for the opportunity to put my drive and enthusiasm to work for our community.

In regards to my education and training, I have obtained an Associate's Degree in Business, a Bachelor's Degree in Business Management and a Master's Degree in Business Administration. I continue attending continuous legal education opportunities for Judges.

Education

Through my Executive Orders, I have acted more quickly than any other government instituting Stay At Home, Masking, and Remote School requirements.

Working together with our elected leadership, our government has continued to function, providing essential services for our Community. I have aggressively and successfully advocated at the federal level to get the financial support we need.

REMEMBER

- \Rightarrow You can vote at any polling site location; you must show proper photo identification
- ⇒ All districts with the exception of District 5; will have only Candidates running for Lieutenant Governor on their ballot
- If you missed the deadline to change your name, address, marital status or district. Your information will stay the same in the database. This WILL

There shall be no electioneering or other political activity within the 50-foot limit area. Election Officials, voter or others within the 50-foot limit shall not force, induce or influence any voter or attempt to do so.
- ⇒ NO CAMPAIGN ATTIRE, PROMOTIONAL ITEMS OR TAKING OF CELL PHONE PICTURES WILL NOT BE ALLOWED INSIDE/OUTSIDE THE POLLING SITE AREA.
- ⇒ ELECTION DAY will require drive-up voting service; please follow signs to route you through this process and please be patient.
