I understand that I am responsible for the actions of the participants of the Dance, that if at any time the Dance becomes disorderly any duly-authorized law enforcement officer may discontinue the Dance. I understand that 48 hours notice to the Community Treasurer and Police Department is required to receive a full refund if the dance is postponed or canceled. However, should a death or reburial ceremony occur within a week and in the neighborhood that is in the vicinity of the scheduled Dance, I agree to be mindful of the death or reburial ceremony and to cancel the Dance and understand that I will be allowed to reschedule once with the Community Treasurer within 30 calendar days after the date of the initial Dance or receive a full refund. I also understand that failure to abide by GRIC Code Title 8, Chapter 4 or other laws of the Gila River Indian Community is punishable by a fine up to \$2,000 and will be prosecuted to the fullest extent provided under provisions of the Criminal Code.
