#### **OVERVIEW:**

This position is located within the Propane Division and is under the direction of the Propane Manager. The driver is responsible for all propane deliveries within the Gila River Indian Community, including set/install and repair tanks and outside lines, conduct system tests and purge cylinders and tanks consistent with company standards and maintaining related documentation. Must be able to work a flexible schedule with afterhours emergency call-outs and communicate clearly and effectively to convey information to new and existing customers.

#### **ESSENTIAL FUNCTIONS:**

- 1. Delivers propane to the community, must be knowledgeable with the Gila River Indian Community
- 2. Ensure all Company and Government safety, policy and regulatory standards are met and maintain zero preventable accidents
- 3. Perform basic outside leak repair
- 4. Maintain safety and compliance records
- 5. Deliver fuel as required and meet established performance standards, such as billable time, productivity and efficient usage of inventory and equipment
- 6. Notifies management of any issues that might impact safety, customer satisfaction, productivity and other established goals and standards
- 7. May be required to work weekends
- 8. Ability to work well with others

#### **SKILLS, KNOWLEDGE AND ABILITIES:**

- 1. High School Diploma, GED or equivalent training and experience
- 2. Must be 21 years of age
- 3. Ability to pass pre-employment DOT physical, drug test

#### OVERVIEW:

This position is responsible for working directly with employees operating motorized field equipment to ensure daily servicing on equipment, light to medium repairs, and keeping accurate records.

#### **ESSENTIAL JOB FUNCTIONS:**

- 1. Operates a large truck to service motorized field equipment.
- 2. Daily services to light and heavy motorized field equipment including fueling, lubricating, scheduled oil changes, and light to medium repairs.
- 3. Inspects tires for wear and proper inflation.
- 4. Visually inspects motorized field equipment for mechanical defects and reports findings to appropriate personnel.
- 5. Checks wheel bearings for tightness and greases wheel bearings as needed.
- 6. Keeps and maintains accurate fuel and maintenance records.
- 7. Demonstrates continuous effort to improve operations, decrease turnaround times, streamline work processes, and cooperatively and jointly provide quality, seamless customer service.
- 8. Assists other service truck drivers with workload.
- 9. Other duties as assigned.

#### SKILLS, KNOWLEDGE AND ABILITIES:

#### Ability to:

- Move heavy objects (50 pounds or more).
- Bend or stoop repeatedly or continually over time (works under equipment)
- Work in a variety of weather conditions with exposure to the elements.
- Learn job-related material primarily through oral instruction and observation. This learning takes place mainly in an on-the-job training setting.
- Willingness to keep current with the latest advancements in equipment through technical training.

- Lift arms above shoulder level.
- Climbs or steps to reach objects.
- Understand and follow oral and written instruction in the English language.
- Work cooperatively with other Gila River Farm employees and the public.
- Enter the cab of a vehicle that is 3 ½ feet off the ground
- Work safely without presenting a direct threat to self or others.
