#### ADDITIONAL INFORMATION NEEDED:

- **CHECK STUBS FOR THE LAST 30 DAYS FOR HOUSEHOLD (WEEKLY, BI-WEEKLY, MONTHLY)**
- **Tribal Identification** from anyone in the household.
- **Proof of Residency and Utility Bills and/or Shelter Expenses.**
- **Award Letters-** If you receive any **UNEARNED Income: Social Security, SSI, GA, Pension, Retirement, VA Benefits, Alimony, Child Support, and AFDC.** We will need a copy of all award letters and/or check stubs of benefits received.

**REMINDER: YOU CAN NOT RECEIVE COMMODITY FOOD IF YOU ARE RECEIVING OR HAVE APPLIED FOR SNAP (FOOD STAMPS).**
