Article XV - Powers of the Gila River Indian Community Council

Constitution and Bylaws of the Gila River Indian Community, Arizona

Section 1. The Council shall exercise the following powers, subject to any limitations imposed by the applicable statutes of the United State and subject further to all expressed restrictions upon such powers contained in this Constitution

- (a) Powers not subject to review by the Secretary of the Interior, except where specifically required by Law,
- 1) To negotiate with the Federal, State and local governments on behalf of the Community.
- To employ legal counsel, the choice of counsel and fixing of fees to be subject to approval of the Secretary of the Interior, so long as such approval is required by Federal Law.
- To prevent the sale, disposition, lease, use or encumbrance of Community lands, interest in lands, or other Community assets.
- 4) To advise the Secretary of the Interior and the Congress of the United States of the wishes of the Community with regard to Federal projects or appropriations for the benefit of the Community.
- 5) To appoint subordinate officials, committees and boards, and to prescribe their duties and powers.
- 6) To provide for the manner of conducting elections.
- 7) To regulate its own procedure.
- 8) To regulate the domestic relations of members of the Community
- To promote and protect the health, peace, morals, education, and general welfare of the Community and its members.
- 10)To expend money in conformance with an adopted budget.
- 11)To expend for any public purpose for any fiscal year an amount equal to ten percent (10%) of the anticipated net revenue according to the current budget.
- 12)To act for and on behalf of members of the Community at the request of such members.
- 13)To administer all Community property.
- 14)To transfer or convey tribal assets to the incorporated Community and to contract with the incorporated Community for management of tribal assets.
- 15)To recognize any district committees, associations or other organizations open to the members of the Community and to approve such organizations, subject however, to the provision that no such committee, association or organization may assume authorities specifically granted to the Council unless by a proper delegation of authority by the Council.
- 16)To levy dues, fees, and taxes on members of the Community.
- 17)To provide for the maintenance of law and order and the administration of justice by establishing a Community

Court and police force and defining the powers and duties thereof.

- 18) To do such other acts of governmental or public nature as are not prohibited by specifically applicable Federal laws or by this Constitution
- 19) To pass ordinances necessary or incidental to the exercise of any of the foregoing powers.
- (b) Subject to review by the Secretary of the Interior
 - 1) To provide by ordinance for the appointment of guardians for minors and mental incompetents
 - 2) To prescribe rules of inheritance which shall not be in conflict with specifically applicable Federal laws.
 - 3) To levy dues, fees, and taxes on non-members residing or doing business within the Reservation.
 - 4) To provide by ordinance for removal or exclusion from the territory of the Community non-members whose presence may be injurious to the peace, health, or welfare of the Community.
 - 5) To regulate the use and disposition of property of members of the Community, insofar as such use and disposition affects the welfare of the Community at large.
 - 6) To establish and relate subordinate organization for business purposes.
 - 7) To purchase or otherwise acquire property of members of the Community for public purposes and to acquire same under condemnation proceedings in courts of competent jurisdiction.
 - 8) To enact criminal and civil codes or ordnances governing the conduct of members of the Community and non-members on the Reservation.
 - 9) To prepare and adopt budgets.
- 10) To pass ordinances necessary or incidental to the exercise of any of the forgoing powers.





> When elected to the Tribal Council, the people that voted you there become your most important concern, your business is the people. Not Individuals. Not off the reservation entities. Our forebears placed our tribal entities here for a reason. They

put them here for the future generations (us) to seek the self-sufficiency that we as a community are trying to achieve.

With the passing of the infrastructure bill in Washington the council must channel the funds to the funda mental facilities and systems serving our districts. Areas such as transportation (roads), power plants (GRICUA), communication systems (GRTI) and our schools.

These are just a few of the items which I feel need addressing. Be confident that I will do my best to bring back trust and accountability to the people of this community. I am merely hoping to find answers to ongoing issues through reasoning. Trying to start over is not the answer. Everything which I have addressed is in the future. 

and civil cases. I also worked at the Salt River Pima-Maricopa Indian Community Court as a Juvenile and Adult Probation Officer. I have taken justice study courses at South Mountain Community College and Mesa Community College along with training seminars at the National Judicial College in Reno, Nevada.

The Associate Judge position requires an extensive time commitment by managing a case load, writing numerous court orders for each case, ruling appropriately in accordance with the facts, evidence, and witness testimony. These are skills that I have learned over the years, and they cannot be mastered in days or weeks. Our Community Court handles civil cases (guardianships, trespass, housing evictions, mental, probate, divorce, child custody and support), criminal cases and traffic citation. The law is detailed, comprehensive and precise and a judge must have knowledge of the court rules and rules of evidence. These rules guide a judge in handling certain types of cases and, most importantly, the types of punishment criminal defendants receive. The Community Code has been updated over the years and now the Community Court exercises criminal misdemeanor and felony jurisdiction much like a state court.

We as Akimel O'otham and Pee'Posh must address historical trauma and mental, physical and substance abuse – all of which are destroying our Community. We should encourage treatment to

address addiction and alternate sentences other than incarceration. The Court must be mindful of each person's rights, ensure access to the law, and apply equal protection principles under the Community's constitution and laws. Our Community Court is one of the largest courts in Indian Country and the workload is great, but I am ready to help on Day One. My best wishes to all the candidates seeking office. Thank you for your support in the past and I humbly ask for your vote in this election.
