<u>COMPREHENSIVE EXECUTIVE ORDER NO. 16 REGARDING</u> <u>CORONAVIRUS PANDEMIC</u>

- WHEREAS, from March 13, 2020 through October 2, 2020, I issued eight separate Executive Orders addressing various aspects of the coronavirus pandemic, ranging from a declaration of a public emergency to a requirement that all persons wear a mask while on the Gila River Indian Community Reservation; and
- WHEREAS, I amended these separate Executive Orders on numerous occasions to extend and clarify them as necessary; and
- WHEREAS, on October 2, 2020, I issued a new comprehensive Executive Order No. 9 that combined these prior Executive Orders into one single order, setting forth the numerous elements of our governmental response to the pandemic; and
- WHEREAS, I amended Executive Order No. 9 on two occasions to both address necessary clarifications, and also to extend its effect until April 12, 2021, in order to provide necessary time to consider important possible modifications to the pandemic restrictions contained therein; and
- WHEREAS, on April 9, 2021, I issued comprehensive Executive Order No. 10, which made various changes including approval of the Tribal Government Return to Work Plan and easing certain restrictions for fully vaccinated individuals; and
- WHEREAS, on June 16, 2021, I issued comprehensive Executive Order No. 11 to address growing concerns regarding new COVID-19 variants; and
- WHEREAS, on August 6, 2021, I issued Comprehensive Executive Order No. 12 to further address recent increases in COVID-19 due primarily to the spread of the Delta variant among unvaccinated individuals; and

- WHEREAS, on August 12, 2021, I issued Amended Comprehensive Executive Order No. 12, which directed that all schools on the Gila River Indian Reservation provide classes virtually until further notice; and
- WHEREAS, on January 14, 2022, I issued Comprehensive Executive Order No. 13, which provided for the reopening of Community schools subject to approval of school reopening plans; and
- WHEREAS, on March 11, 2022, I issued Comprehensive Executive Order No. 14, which continued the Community's response to the COVID-19 pandemic; and
- WHEREAS, on July 22, 2022, I issued Comprehensive Executive Order No. 15, which addressed the reopening of the Community's schools for the 2022-2023 academic year; and
- WHEREAS, the Community's Tribal Health Department has issued updated COVID-19 Guidance for GRIC Departments, Entities and Organizations, effective September 5, 2022, which requires issuance of an updated executive order; and
- WHEREAS, as part of our pandemic response, the Community has emphasized the importance of COVID-19 vaccines and boosters and made them available to all eligible members of the Community, all employees of the Community and its enterprises, all Community residents, all residents of any household in which a Community member resides, and all teachers who teach at a school located on the Gila River Indian Reservation; and
- WHEREAS, it continues to be the policy of the Community under this Executive Order to encourage all those eligible to receive a vaccine take their vaccine and any recommended boosters at the earliest opportunity; and
- WHEREAS, the Community must continue to be diligent in its efforts to address the coronavirus pandemic and take aggressive measures to continue to protect our Members and the public at large from this disease and the variants that continue to affect our Community.

NOW THEREFORE, I, Stephen Roe Lewis, Governor of the Gila River Indian Community, through the authority granted to me in the Constitution and Bylaws of the Gila River Indian Community and Title 1 of the Gila River Indian Community Code, hereby issue this Executive Order No. 16 Regarding Coronavirus Pandemic and order as follows:

First, this Executive Order No. 16 includes all requirements and measures that are to remain in effect from this date until the date ascribed herein for expiration, or until this Executive Order No. 16 is otherwise amended or rescinded by a subsequent amendment or Executive Order.

Second, for purposes of this Executive Order No. 16, the following terms shall have the definitions set forth below:

- a. "Community COVID-19 State of Emergency" means the public health State of Emergency in the Gila River Indian Community regarding the COVID-19 Pandemic declared in the Third Clause of this Executive Order No. 13.
- b. "Community Public Safety Departments" means the Gila River Police Department, the Gila River Fire Department, the Department of Rehabilitation & Supervision, the Tribal Health Department, and the Office of Emergency Management.
- c. "COVID-19 Pandemic" means the ongoing pandemic of coronavirus disease 2019 (COVID-19) caused by severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2).
- d. "First Responders" means any individual directed to respond to any call for health care, emergency or police call, or essential services, including, without limitation the following:
 - Employees of the Gila River Police Department
 - Employees of the Gila River Fire Department
 - Employees of Gila River EMS
 - Employees of Gila River Health Care Corporation
 - Utility workers who are conducting work within the Reservation, including employees of Gila River Indian Community Utility Authority and Gila River Telecommunications Inc.
 - Employees of the Tribal Health Department
 - Employees of Department of Community Housing who work in the field and interact with the public
 - Employees of the Community Services Department who work in the field and interact with the public
 - The Community Manager and all Department Directors
- e. "PHI" means protected health information.
- f. "Reservation" means the Gila River Indian Community Reservation.

Third, I hereby declare that there is a continued public health State of Emergency in the Gila River Indian Community regarding the COVID-19 pandemic, which shall continue until further notice.

Fourth, I am rescinding any COVID-19 limitations placed on employee business travel and directing the Tribal Health Department to issue an updated employee personal travel

directive, pursuant to Resolution GR-034-21, lifting most restrictions on employee personal travel. Employees should continue to follow COVID-19 precautions while traveling and are reminded that they are responsible for knowing whether there are any COVID-19 related entry requirements or restrictions for the places to which they travel, including testing or quarantine requirements.

Fifth, the limitations on indoor and outdoor gathering sizes are lifted. This means that indoor and outdoor gatherings have no in-person limit provided that physical distancing can be maintained. This includes faith-based organizations in the Community. Organizations or individuals hosting or sponsoring gatherings should continue to ensure that measures are followed to prevent and mitigate the spread of COVID-19.

Sixth, price gouging is unlawful on the Gila River Indian Reservation. GRIC Code Section 13.209 provides that "unconscionable and other unfair business practices" are grounds for the revocation of a business license. Individuals or businesses that engage in price gouging in the Community are subject to a revocation of their business licenses and non-members will be subject to exclusion from the Community under GRIC Code Section 8.101(C), which prohibits unfair business practices. I hereby direct law enforcement to fully and vigorously enforce these laws on the Gila River Indian Reservation to ensure that no business takes undue advantage of the COVID-19 Pandemic.

Seventh, I hereby declare a continued moratorium on any new evictions being initiated by the Department of Community Housing (DCH) or the Department of Housing Development (DHD) until the expiration of the Community COVID-19 State of Emergency. This moratorium shall not apply to evictions based on criminal activity.

Eighth, I hereby designate and authorize the following departments, programs and entities to situationally receive PHI until the expiration of the Community COVID-19 State of Emergency:

- a. All First Responders;
- b. All Community Public Safety Departments;
- c. The Gila River Health Care Corporation;
- d. The GRICUA Administrator, but solely for utility workers who are conducting work within the Reservation;
- e. The GRTI Administrator, but solely for utility workers who are conducting work within the Reservation;
- f. The Community Services Department Director, Deputy Director, District Coordinators, and Assistant District Coordinators;
- g. The Department of Community Housing Director and Deputy Director;
- h. All field employees of CSD and DCH who are required to interact with the public;

- i. The Tribal Social Services Child & Family Welfare Administrator and Crime Victim Services Coordinator;
- j. The Tribal Health Department; and
- k. All Community department directors.

Ninth, departments, programs and entities identified in the Eighth Clause of this Executive Order No. 16 shall follow the guidelines contained in "COVID-19 and HIPAA: Disclosures to Law Enforcement, Paramedics and Other First Responders and Public Health Authorities," published by the United States Department of Health and Human Service, Office of Civil Rights.

Tenth, all Community departments and employees shall continue to comply with the comprehensive "Tribal Government Return to Work Plan," the "COVID-19 Guidance for GRIC Departments, Entities and Organizations," as updated, and their department or program plans. All Community services will continue to be provided at 100% until further notice.

Eleventh, under the Communicable Disease Ordinance, GRIC Code Title 17, any individuals who (i) have tested positive for COVID-19, have been diagnosed with COVID-19, or have been advised to self-quarantine by a health care professional or the Tribal Health Department, and (ii) do not submit to a voluntary quarantine may be subject to a written quarantine directive by the Tribal Health Department and court-ordered quarantine by the Community Court, enforceable by the Gila River Police Department. All Community Members and residents of the Reservation are strongly encouraged to follow the directions of their health care providers and the Tribal Health Department with respect to measures addressing the COVID-19 Pandemic.

Twelfth, the Gila River Police Department is authorized and directed to enforce the Eleventh Clause of this Executive Order No. 16 under the applicable provisions of the Gila River Indian Community Code.

Thirteenth, until further notice, all persons including Community members, employees and visitors over two (2) years of age who are present within the boundaries of the Reservation shall wear a protective face mask while inside common areas of any tribal government building or while inside any school located within the Reservation, regardless of vaccination status. All Community employees shall continue to participate in daily COVID-19 screenings. All Community departments, schools and Reservationbased employers and businesses shall make protective face masks available for all employees and visitors. All persons who are subject to the criminal jurisdiction of the Community who violate this face mask requirement shall be subject to a citation under the Community's Criminal Code. All non-Indians who violate this face mask requirement shall be subject to a citation under the Community's Civil Trespass Code. **Fourteenth**, I hereby direct that employees of the Community must be tested for COVID-19 as directed until further notice; however, the Community will be scaling down its mandatory COVID-19 testing program. Employees are encouraged to continue using home COVID-19 tests and directed to test immediately with their healthcare provider if they are experiencing any COVID-19 symptoms, and shall follow workplace policies regarding returning to work.

Fifteenth, I hereby direct that the Community shall also make COVID-19 testing available, subject to availability of funds, to the following groups of individuals on a regular basis or as directed until further notice:

- Community Council and elected and appointed officials of the Community
- Employees and students of all schools located on the Reservation
- All Community Members, including Urban Members residing in the surrounding communities
- Employees of all wholly-owned Community entities or operated entities, with the consent of those entities
- Employees of Boys & Girls Clubs on the Reservation
- Such other groups of individuals as may be designated by the Executive Office in writing

Sixteenth, I hereby direct that all schools located on the Reservation shall continue to operate pursuant to their approved school reopening plans under the direction of the Education Standing Committee and Health and Social Standing Committee.

Seventeenth, I hereby direct each school on the Reservation to continue their plans for providing meals for students and other school-aged children who are learning remotely, using existing resources that each school has available to it. To the extent such meal programs exceed the resources available to any such school, such school may request such funding as may be necessary from the Community Treasurer. Such meal plans must include adequate public health safety and COVID-19 prevention measures.

Eighteenth, due to staffing shortages resulting from the COVID-19 pandemic, I hereby declare a continued moratorium on the issuance of permits for dances under Title 8, Chapter 4 of the Gila River Indian Community Code until such time as the Dance Ordinance is amended to ensure that dances may be safely conducted in the Community.

Nineteenth, all individuals who are not up to date with their COVID-19 vaccinations, in accordance with guidelines from the Centers for Disease Control and Prevention, and who reside within the Reservation are strongly encouraged to stay at home as much as possible and take other precautionary measures.

Twentieth, I urge all Community members, employees, and all others eligible to receive a COVID-19 vaccine or booster do so at the earliest opportunity possible in order to help ensure the health and safety of our entire Community.
