Some of the immediate concerns I'd like to address is the violence that has taken over our Community be enacting laws and ordinances to be imposed and adhered to; addressing the needs and deficiencies in our tribal departments, enterprises and entities; assisting and addressing our homeless members; lack of housing and efficient, sustainable processes of building; addessing generational trauma and its effects on our members; supporting our Urban members and their needs; looking at alternative measures at addressing our diabetes epidemic and working collectively with all Council Representatives to get back to the true roles and responsibilities of Council reestablish to our Legislative Branch.

Along with the institutional knowledge I carry from past Council experience, I also bring business management experience having served on the Wild Horse Pass Development Authority Board of Directors and currently on the Sand & Gravel Board of Directors, both for a period of six (6) years, twelve (12) collectively. I understand the distinction between government and business. The technical experience of qualified board members is imperative to continuing to build our revenue for our Community and the benefit of ALL community members.

- Protecting our natural resources


It is my hope I get to personally connect and hear your concerns as we near the election.



- Please do not bring children with you, they will not be permitted to enter the polling site.
- If you missed the deadline to update your voter registration. This will not prevent you from voting. You will be required to sign your name as shown in the AutoVote (voter registration) database.
- During the time the polls are open, no one shall loiter within the 50-foot limit area. Except voters who have not voted and Election Officials.
- No Campaign Attire, Candidate Promotional Items, Recordings, or pictures are allowed inside the Polling Site.
- All updates will require you to fill out a Voter Registration Application with the District Election Judge or Tribal Elections Office the day after the election.
- Keep Your Phone in your purse or pocket. If you are seen using your phone, you may be asked to remove it from the Polling Site.
- If you encounter any issues that prevent you from voting, such as those listed above, please don't hesitate to notify the Tribal Elections Office immediately at (520) 562-9758 or 9735. We're here to support you and ensure your right to vote is upheld.
- It's important to note that the tabulation of votes at the end of Election Day is not considered official until the Gila River Indian Community Council certifies these results.

## **Absentee Voting**

## ABSENTEE VOTING PERIOD OPENS: April 3, 2025 CLOSES: May 5, 2025 at 5:00 p.m.

#### 2.111 - Absentee Voting

B. A person shall be permitted to vote absentee if the voter expects to be absent from his District at the time of the election, or if the voter is physically unable to go to the polls.

You will have a variety of options to absentee vote in this election.

- 1.) Absentee Vote by Mail. Complete the enclosed Absentee Ballot Request Application.
  - 1. Fill out the form and mail it to the Tribal Elections Office.
  - 2. Once the application is received and verified that you are a registered voter, the Tribal Elections Office will mail you an absentee ballot.

Once you cast your absentee ballot, remember to fill out and sign the back of the Official Ballot Envelope and mail it back promptly to ensure it is RECEIVED by 6:00 p.m. on Election Day - May 6, 2025.

If you don't have enough time to mail your ballot back or prefer to return it in person, you can:

- You can drop your ballot off at the Tribal Elections Office at 291 W. Casa Blanca Rd., Building 9, Sacaton, Arizona.
- You can drop your ballot off with the District Election Judge at any polling site on Election Day.

**PLEASE NOTE:** If you receive your absentee ballot in the mail and decide to vote in person, you must surrender it to the election judge at the poll site.

- **2.) Absentee Vote with District Election Judge:** If you live within the Gila River Indian Community and would like an Election Judge to assist you in voting absentee, please DO NOT request an absentee ballot. Instead, contact your District Election Judge, who will have absentee ballots. Contact the Tribal Elections Office for District Election Judge information.
- Also, on the last day of the Absentee Voting period, District Judges will be at their respective District Service Center/Multi-Purpose Buildings for absentee voting from 3:00 p.m. 5:00 p.m.
- **3.) Absentee Vote at the Tribal Elections Program office.** Drop in to cast your absentee ballot during office hours Monday through Friday, 8:00 a.m. to 5:00 p.m.
