The Gila River Indian Community, Department of Community Housing (as of 2025) owns and operates over 700 housing unit within Districts 1-7. Each year DOCH prepares the Indian Housing Plan (IHP) and submits to the Housing and Urban Development (HUD) which includes the goals, objectives, and tasks for the implementation by DOCH as recipients and other entities as sub-recipients. HUD Native American Housing Assistance Self-Determination Act (NAHASDA) defines the eligible categories and activities by which block grant funding may be expended. Each program includes the eligible activity, its planned outputs, intended outcome, who will be assisted, and types and levels of assistance. Each of the eligible activities has a specific, measurable output. The goals of the DOCH are best accomplished by enacting policies and procedures that will govern the action of the Department and its tenants that it serves. Additional, regulations governing the Department's programs are contained in 24 CFR § 1000.

Administrative Division

This division provides a variety of essential functions to support the department and ensure that business functions smoothly on a daily basis, including warehouse operations and support to all other divisions within the department.

Engineering Division

This division is responsible for civil engineering design and construction of new potable water infrastructure, sanitary sewer collection infrastructure, and water/wastewater treatment facility projects. In addition, the engineering branch reviews all residential, commercial, and governmental projects throughout the Community as part of the Community Technical Stakeholders Committee and provides direction on projects outside of the committee as well.

Solid Waste Division

This division provides for the collection and disposal of residential and commercial trash throughout the Community, as well as recycling services.

Water and Wastewater Systems Division

The Plant Operations branch provides essential 24-hour service in the operation and maintenance of the Community's water and wastewater treatment systems, as well as system monitoring and compliance testing. The Systems Controls branch provides essential 24-hour service in monitoring, maintenance, repairs, and remote data control over all Supervisory Control and Data Acquisition (SCADA) equipped water and wastewater systems.

Fleet Management Division

This division provides preventive maintenance and general repair services to Community vehicles and equipment (approximately 1300) including cars, trucks, vans, trailers, DPW heavy equipment, and small engine equipment.

Department of Rehabilitation and Supervision (DRS)

Services Offered: The mission of the Department of Rehabilitation and Supervision (DRS) is to serve and protect the Gila River Indian Community by providing safety, security, care, custody, and control to a Native American mixed-gender multi-classification juvenile and adult offender population. DRS houses misdemeanor and felony adult inmates for up to 9-years per the Tribal Law and Order Act. DRS-Juvenile facility houses juveniles from 8-18 years of age for various status offenses up to and including serious crimes.

Community Council Resolution GR-88-01 established the Gila River Indian Irrigation & Drainage District (GRIIDD) for the purpose of operation, maintenance, rehabilitation, establishing and realigning water waterways within the Reservation boundaries. GRIIDD will serve land from the Community District 1 to Community District 7 including Community (tribal) and allotted land. The Community Council vested GRIIDD with the authority to manage and deliver water received by the Community for irrigation and other purposes. The Gila River Indian Irrigation and Drainage District made up of several divisions, including the Agriculture Development Program, Operation and Maintenance Division, Irrigation Division and 4-H Youth Development. Each Division Manager reports to the General Manager of the Gila River Indian Irrigation and Drainage District.

Travel staff are part of the Accounts Payable section and work to process travel requests, reconcile travel expense reports to travel expense statements to pay the credit card bills.

Payroll

The Payroll staff works directly with Human Resources and Benefits department on staff hourly wage rate and benefits packages for each Community employee. Payroll then works with Community departments and Districts to maintain reliable time keeping records through the Community's electronic timekeeping system. This ensures Community employees are timely and accurately paid for time worked. Payroll processes bi-weekly and off-cycle payrolls to ensure Community employees are compensated for time worked.

Fixed Assets

Fixed Assets is responsible for properly accounting for all assets that includes, but is not limited to land, infrastructure, historical collections, furniture, fixtures and equipment that have a useful life of more than one year and above an initial purchase price of \$5,000.

Special Revenue

Special Revenue section oversees departmental expenditures to assist Community departments and Districts in properly maintaining their department/grant/contract budget ledgers. This helps the department and District staff in monitoring their spending levels and help ensure spending is within the approved budget spending limits.

Planning & Financial Reporting

Planning & Financial reporting section reconciles bank statements, account balances, investments other applicable financial documents to endure the Community's financial statements are balanced and fairly reported, free of material misstatement. The Planning section takes the lead on the annual single and financial audits of the Community. Planning also works to develop the annual Indirect Cost Proposal to the federal cognizant agent.

The GRIC Ordinance GR 14-09 mandates that communicable disease reports (CDRs) be collected, analyzed and monitored for disease trends and outbreaks. The CDRs are generated from the Arizona Department of Health Services Medical Electronic Disease surveillance Intelligence System (MEDSIS) designed for State, County, and Tribal Users. CDRs are also received from Gila River Health Care (GRHC). DSP also works with GRHC Public Health Nursing, Gila River DRS Nurses, School Health Nurses, and Regional Treatment Center.
